2. Approval of Minutes – November 1, 2012 Meeting

Bob Day made a motion to approve minutes as presented. Kathe Brewer seconded motion. Unanimously approved.

3. Presentation - Ginger Corless, A1A Action Committee, FDOT, gcorless@hhidesign.com

Ms. Corless presented the AIA Multimodal Corridor Planning and Engineering Analysis project. The project covers proposed improvements to A1A from SR 528 in Cape Canaveral to the Pineda Causeway. The first phase includes gathering data, identifying potential projects, and data gathering. The second phase will be to develop an implementation plan. So far, briefings have been presented to the Cape Canaveral Council, the Cocoa Beach City Commission, and the IRLNSB Coalition, today.

The project vision statement: "The vision of SR A1A is to have a corridor that functions as a safe and efficient multimodal corridor that connects and supports the economic viability of several communities. The corridor should be aesthetically pleasing while providing a sense of community through innovation, design and connectivity."



In many areas there are right of way (ROW) issues, including areas where the actual legal ROW is uncertain. This is critical because FDOT can only undertake projects within the state ROW. Other projects must be undertaken by other governments or groups. Examples of data gathering include prior studies, aerial photography, site documentation, stakeholder inventories, and crash studies. Themes which have emerged from study and public discussion are beautification, pedways, way finding, bus shelters to have a common theme, enhanced intersections, and utility issues. Some initial strategies have been drafted, and the next stops will be to adopt strategies, establish partnerships, and in Phase 2 to initiate plan activities.

Some have expressed a desire for underground utilities, which have both positive (hurricane resistance) and negative (difficult to repair) aspects. But the two main drawbacks are cost (\$500,000 to \$4 million per mile) and FPL's policy to use private easements only.

- A. Sustainability Committee Mike Palozzi There was a committee teleconference call 11/29.
 - Donor Plan The check from Ron Jon's was a good start. New we need to determine who
 the next two on our list of major business we should pursue. That should be a Byway
 Coalition goal for 2013. Celeste Henry suggested contacting political candidates who are
 required by law to donate any remaining campaign funds.
 - Community Awareness -
 - Presentation Schedule Tim Ford will make a brief presentation tonight to the City of Palm Bay Council, and a full presentation to the Roseland Community Association in February.
 - O Marsha is attempting to get more newspaper coverage, e.g., a press release on our 2012 accomplishments.
 - Marketing Plan This should be a priority task for 2013, perhaps narrowing our focus to market targeted groups. Mike displayed a brochure from another Byway, and reported that a W. Va. Byway produces a guidebook which produces about \$100,000 a year in advertising revenue.
 - Member recruitment Rodney Smith suggested that people need a reason to come to our meetings and participate. To promote interest we should consider events and activities to spark interest. We have an asset in the Lagoon House. Tim suggested we may be able to do shared sponsorship of events, and Byway Coalition members should continue to represent us at other community events. He also suggested pursuing creating a display banner, which would cost about \$50. There was unanimous consent to Bob Day's motion that Pres. Ford be authorized to proceed with this project.
- B. Website Committee Nicole Holbrook The web site hosting issue has been resolved. The interactive map is now working. Last month the site had 461 visits, 84% new visitors. The top referrers were Fellsmere and Google.
 - On-line store Kathe Brewer This could be established at a cost of about \$30 per month, with over 1000 items to choose from. It would be easy to change the menu on our e-store.



The product she is considering will be available in January. Another option would be for us to purchase supplies of some merchandise ourselves to distribute or sell. She will present more details later.

- C. Elections Beth Mitchell could not be here today, but is working on a proposed slate of officers.
- D. FDOT Scenic Byway Coordinator Garry Balogh FDOT is shifting the focus from creating new byways to marketing the existing byways. They will market the 25 byways at welcome centers. In February or March the revised Byway Plan will be presented to the District Secretaries. The future looks good for continued FDOT byway support.

- Work is proceeding on the Fellsmere Byway grant for the new welcome center. They have had meetings with FDOT District 4 and are preparing necessary paperwork for FDOT. The plans are done, and construction will start next year.

- Vince Lamb announced that there will be a Brevard Wildlife Corridor Expedition in April. This will be a

2. Approval of Minutes - October 4, 2012 Meeting

Beth Mitchell made a motion to approve minutes as presented. Richard Stillwagon seconded motion. Unanimously approved.

3. Presentation – Kevin Lowry, Pelican Island National Wildlife Refuge

A presentation was shown regarding the plans of how Pelican Island National Wildlife Refuge (PINWF) is reconnecting with the City of Sebastian. They are offering free wildlife tours to the public which are very popular. They have an E-Tram which is an upscale golf cart that can fit several people and gives tourists the ability to feel nature without having to hike or disturb the natural habitat. A second E-Tram was added which will help with accommodating more tours. All field gear such as binoculars are provided. Tours run November — March and are every other Wednesday; call for reservations. Type of species that can be viewed are the osprey, water fowl, Snowy Egrets and Rosette Spoonbill. A guided night tour called "Owl Prowl" is offered on select nights at 8pm. Photography workshops will be held as well. PINWF has been getting the local high school color guard, ROTC, and Drama Club involved with events. Combining arts with conservation and education. The Pelican Wildlife Exhibit was moved from the Lagoon House to the Sebastian River Chamber of Commerce; will be expanding the exhibit by adding panels of information along the sides and having it be an interactive display. PINWR's main goal is to have a visitor center to tell the story about conservation; would like to be located along Indian River Drive and the visitor center will be Old Florida style. Pelican Island was the first National Wildlife



Refuge and now there are over 500. Discussed the need to keep track of visitors; trails will have trailheads and kiosks; need to interact with all ages; each method will tell a brief history.

4. Committee Reports

- A. Sustainability Committee Marsha Cantrell There was a teleconference call on 10/24 and the call was very short as most members were also unable to participate.
 - Donor Plan The check from Ron Jon's was received and deposited. It was agreed to create
 a certificate of appreciation and insert it into a wood plaque. Examples of draft certificates
 were passed around and it was agreed upon which style to use and to use 8 ½ x 11 sized
 paper, arching the top line, deleting the accreditation logo, add signature lines, and increase
 size of our IRL logo. Bob Finck agreed to finalize the certificate and Marsha will purchase the
 wood plaque.

Bob Day made a motion to allow spending of up to \$50 on a nice, wood plaque. Beth Mitchell seconded motion. Unanimously approved.

Discussed continued commitment to provide the outlined products per sponsorship level; need to formalize the product process and get in place; Kathe Brewer will provide options of Café Press and printing on demand. The next step for the Committee is to look at who the major businesses/organizations are along the corridor. Waste Management and Waste Prowere suggested to be added to the list.

- Community Awareness Tim Ford advised he made a presentation on 10/23 at the Ted Moorhead Lagoon House.
- Presentation Schedule Tim will be presenting the to Roseland Community Association in February. The next Sustainability Committee agenda will contain discussions on how to target community awareness to the next level. In December, there will be a presentation to the Palm Bay City Council. It was agreed that with elections coming up government agencies/organizations should be targeted and get on their agendas. Whomever adopts a meeting month will take on the responsibility of inviting local officials within the area the meeting is being held, as well as schedule a presentation.
- 2013 Calendar Marsha asked everyone to look at the 2013 calendar and adopt a meeting that would involve scheduling a presentation and a meeting location if one is not noted. Beth Mitchell adopted February which has a location, but needs a presentation. The annual Birding Festival was discussed and it was suggested to put a brochure in each of the participant bags. There are usually about 1000 bags. Bob Day will get the information on how many brochures will be needed. Nicole Holbrook will have a sign in sheet and brochures at the Sebastian Clam Bake the 1st weekend in November. Suggestion was made to purchase a banner to use at events.

Tim Ford, President, advised there was a misunderstanding of meeting dates at the Sebastian Inlet Fishing Museum so our meeting location was changed to Marsh Landing Restaurant and Mark Mathis will be discussing the Byways grant that was awarded to the City of Fellsmere. We will schedule a future meeting at the Sebastian Inlet Fishing Museum.

2. Approval of Minutes – August 2, 2012 Meeting

Bob Day made a motion to approve minutes as presented. Susan Adams seconded motion.

Unanimously approved.

3. Presentation – City of Fellsmere; Byway Grant

Mark Mathes distributed a handout and discussed the \$316,500 Scenic Byway grant for the Welcome Center that was awarded and requires a \$148,000 local match. There will be a meeting on September 17th to review the scope and the local match funds. All permits for the 86 acre property are in place due to a previous LWCF grant. The Center will be located off the interstate and will highlight the whole Byway and not just the Indian River County portion. Park amenities will include: rail trail, camping, adventure playground, observation tower,

picnic area, trails, wetland overlook, and a challenge course. A sign will be installed along the highway highlighting the Welcome Center. The Welcome Center will be Old Florida Style and modeled after the Kitchen Switch Building which is at the Regional Park to give a uniform theme. The grant was marketed as showing the experience to the traveler along the byway and provide a respite for travelers.

4. Reports of Committees

A. Sustainability Committee – Marsha Cantrell

A teleconference was held on 8/21. Bob Finck discussed the Community Participation Program (CPP) which has been compiled and is one of the 4 remaining tasks to complete for Level 1 accreditation. The byway mission statement was discussed and modified to add the specific location of being located along the central east coast and history of the Kennedy Space Center and first landing of Juan Ponce de Leon.

Mission Statement:

"The mission of the Indian River Lagoon National Scenic Byway Coalition is to encourage visitors to the 195 mile byway on Florida's central east coast to experience the byway's unique natural, historic and cultural resources. These resources include the most diverse estuary in North America with over 4,000 species of plants and animals, and both the home of the Kennedy Space Center and site of Juan Ponce de Leon's first landing."

Bob Day made a motion to approve the byway mission statement as presented. Susan Adams seconded motion. Unanimously approved.

B. Website Committee – Nicole Holbrook

Nicole Holbrook is attending the Governor's Conference on Tourism in Tallahassee and Marsha provided her report: Travis Johnson with TranSystems is searching for someone familiar with our sites programming that could fix the interactive map. Received an email from an engineering firm in Miami who is proposing to perform a planning study for FDOT on widening Malabar Road. Nicole forwarded the email to Tim Ford. Google Analytics: 345 visits; 276 from US and 173 from Florida.

C. Public Relations Committee – Susan Adams – No further report.

D. Bylaw Review Committee – Richard Stillwagon

Richard Stillwagon, Beth Mitchell and Tim Ford worked on the bylaws and presented the proposed changes. It was agreed to review and vote on each section where changes are proposed.

<u>Article III Membership</u> – Proposed changes: one class of membership instead of several classes of members; all members have one vote; Board of Directors may establish dues and responsibilities of members.

Beth Mitchell made a motion to approve proposed changes. Susan Adams seconded motion. Unanimously approved.

<u>Article IV – Meetings</u> – Proposed changes: the Annual membership meeting to be held each year in January; a quorum shall consist of a majority of voting Board Members; members may

participate via telephone that has a speakerphone during a meeting if majority of members approve.

Beth Mitchell made a motion to approve proposed changes. Susan Adams seconded motion. Unanimously approved.

<u>Article VI – Officers</u> – Proposed changes: names of Officers be deleted and list positions; deleted the words "of the Board" under Duties of Officers.

Beth Mitchell made a motion to approve proposed changes. Susan Adams seconded motion. Unanimously approved.

Article V – Board of Directors – Proposed changes: the composition of Board Members to be at least 8 but no more than 11; the term period for an elected Board Member will be three years; deleted the details regarding the Nominating Committee and left it up to the President of the Coalition to designate who is in charge of the Nominating Committee; prior to the annual meeting the Nominating Committee shall present the candidates to the President; seating of new Directors occurs after their election at the annual membership meeting. Discussed that as it stands now in the bylaws, all members present can vote on issues; it is proposed the flow be the membership elect the Board and the Board select the Officers. Only the Board Members can vote on issues. Discussed that there can still be an attendee vote for input and be not-binding, and the Board will vote the final decision. The pros are that the Board is a governing body, keeping consistency with how the body is governed, and the Board has responsibilities because the organization is a not-for-profit corporation; the cons is that it opens the availability to potentially change the direction of the organization.

Bob Day made a motion to approve the proposed changes and to approve that general members elect the Board, the Board elect the Officers and general business of the organization is handled and voted on by the Board. Kathe Brewer seconded motion. Mark Mathes asked if there was a term limit. Answer: No there is not. Unanimously approved.

Beth Mitchell made a motion for the Bylaw Committee to rewrite bylaws to reflect the adopted changes. Susan Adams seconded. Unanimously approved.

5. Reports of Officers

- A. President Tim Ford Purchased and read the book Jeff Caster discussed at the last meeting, *The Winter Sailor*. It is a very good book and easy reading. The Coastal Partnership Initiative grant application period is open; grant applications are due October 31st.
- B. Vice President Richard Stillwagon Nothing further to report.
- C. Secretary Marsha Cantrell Marsha advised Bob Day had forwarded a picture of a byway sign and asked that Bob explain. Bob stated he was at Ron Jon's Surf Shop where he saw an 18" decorative sign that shows the IRL Scenic Byway sign and logo. Tim Ford will talk with Garry Balogh, FDOT, about the sign and draft a letter and send a donor plan package to Ron Jon's and ask for their participation with the Coalition.
- D. Treasurer Nicole Holbrook Marsha gave report: There is \$324 in the account which is in line with the annual budget.

6. Old and Unfinished Business

- A. Accreditation Once the bylaws are finalized with the adopted changes, they will be sent to the consultants at Corridor Solutions; they must be signed by Tim Ford and Marsha Cantrell.
- B. Planning upcoming events with Coalition Participation Marketing Sign in sheets and should be used at each of the events we attend and pictures too. They are a tool to show that we have attended events and reached out to the community.
- C. Preparation of the End of Year Report Anticipated due date of October 1st Tim/Mike/Bob completed the report.

- It was suggested that a standard bullet item for the Scenic Highway Coordinator be placed on the Agenda.
- Discussed the Florida Scenic Highway Program proposed work plan package.
- A national byway article on the IRL Byway will be coming out and will list the website.
- Beth McMillen informed there will be an Eco-Days Open House at the Ted Moorhead Lagoon House in Palm Bay on October 6th; the time is still to be determined.
- November's meeting will be held at the Sebastian River Area Chamber of Commerce; Kevin Lowry from Pelican Island National Wildlife Refuge will be the speaker. Marsha spoke to Charlene Neuterman and the City of Cocoa will be hosting a meeting in January/February.

2. Approval of Minutes – June 7, 2012 Meeting

Marsha Cantrell advised the last sentence of Section 5.A. should read "The \$500 Wildflower grant was submitted and is pending". Richard Stillwagon made a motion to approve minutes as amended. Vince Lamb seconded motion. Approved as amended.

3. Presentation – Jeff Caster, Florida Department of Transportation Scenic Byways Program
Jeff Caster explained that he received a lot of history and ideas from Mariano Berrios to help
direct the byway program. He explained there is a book called *The Winter Sailor* by Carolyn Baker
Lewis that details the 1878-1888 travels of Francis Stebbins (Jeff's great uncle) from Michigan to
Florida where he discovers and spends time on the Indian River Lagoon. Jeff explained the State is
still working at the same level of funding when there were zero byways and now there are 23. In
order to obtain funding there must be a return on investment. He showed a short video and
PowerPoint presentation about scenic byways. There is a draft work plan for 2012-2017 that is

under review and will go to CME and CAG for review. It contains goals and strategies. The focus of the National Byway Program has shifted from intrinsic resources to sustainability, investment and strengthening, although they have no funding. FDOT can use state monies for marketing and promoting Byways. The State wants to rebrand how to navigate the byway from vehicles and scenic to biking, walking, etc.

4. Reports of Committees

- A. Sustainability Committee Marsha Cantrell
 - There have been 2 teleconference call meetings; June 27th and July 31st.
 - The focus has been on sponsors and donors. There is a need to show a potential donor where the Coalition is headed and the projects to be undertaken. A draft donor packet was distributed and there are some edits to be made. This will cost the Coalition some money, but will be inexpensive. The packet could be added to the website. Please review and provide comments to Bob Finck.
 - B. Website Committee Nicole Holbrook Google analytics from June and July: 567 visits; 85% were new visitors.
 - Travis Johnson, TranSystems Discussed that the ultimate goal of the website would be a place to list events, informative brochures, and maps. Who will be the person(s) to make updates to the website. The cover page needs to be updated and reformatted, scrolling banner, add online store, minutes and change over the format of the website to Word Press. Word Press is user friendly and easier to make changes and updates. New and updated content will draw people to the website. He will get with Garry Balogh and discuss.
 - On-line store Kathe Brewer is continuing research and there is lots of free stuff available that could be used. She needs to know how it is going to work and will come back with more information at the next meeting.
- C. Public Relations Committee Susan Adams Brochure distribution list was updated.
- D. Bylaw Review Committee Richard Stillwagon
 - Recommendations on the accreditation package have been received: need to improve the mission statement; revise quorum requirements; include language regarding teleconference participation; define the number of director slots to fill or eliminate; changes to the board manual and bylaws. Would like to get all the recommendations addressed within the next month so Level 1 Accreditation can be established. If you see anything within the bylaws that need to be changed, let Richard know. Bylaw changes will be drafted and brought before the Coalition for approval.

5. Reports of Officers

- A. President Tim Ford One of the goals of the Coalition was to get rid of billboards along the Byway; so far 5 have been removed. FDOT has a beautification grant for State roads that must be submitted by October 1st.
- B. Vice President Richard Stillwagon nothing further to report.






The Preserve Engineering Plan





3. Presentation – Enchanted Forest Sanctuary Management and Education Center/Environmentally Endangered Lands Program Presentation - Xavier de Seguin des Hons.

Xavier narrated a power point presentation. The EEL Program's mission is to protect the biodiversity through responsible stewardship of Brevard County's natural resources. The EEL Program was created in 1990 by voter referendum and was granted \$55M in bonds to purchase land for conservation. Approximately 20,000 acres have been protected; there are 65 threatened/endangered species on the land such as the Scrub Jay and Gopher Tortoise. There is a Selection Committee and a Management Committee set in place to decide what land will be purchased based on science and habitat/species; only land that has a willing seller can be purchased. The EEL Program purchases scrub as only 10% remains. Land Management requires research, removal of invasive exotic plants and animals, the planting of native vegetation,

vegetation reduction, prescribed burns and trash removal. The Enchanted Forest has a wealth of plant life as the tropics/subtropics merge here. The Barrier Island Sanctuary focuses on beach and sea turtles. Pine Island is the newest conservation area and contains the oldest house in Brevard County and mastodon tusks were found. Xavier advised that Joanie Faulls would provide a walking tour of the facility after the meeting for those that are interested.

4. Reports of Committees

- A. Sustainability Committee Marsha Cantrell teleconference meeting held 4/24/12.
 - Community Awareness/Presentations/Events The Roseland Community Association presentation was postponed. The presentation to the League of Cities will be to inform who we are and hand out brochures and not present the typical PowerPoint presentation. The second Friday of each month is the Downtown Melbourne Friday Fest and Kathe Brewer volunteered to hand out brochures but there is a \$30 fee for a booth. Additional ideas on the types of future presentations and speakers were discussed. For June's meeting, Chevon Baccus will be providing a presentation on the Eau Gallie Arts District. No meeting in July. We hope to have Dave Castor, DOT/Byways, as our August speaker.

The PowerPoint showed how the islands were formed and how they will eventually disappear. He also spoke about the work and research done on the islands.

Jerry Stansfield provided a presentation of the City of Cocoa Beach. He discussed projects completed in 2011 and projects coming up in 2012. In 2011 the City celebrated their 86th anniversary. Cocoa Beach supports the Space Coast Art Festival and the Christmas Boat

Parade. The Ocean Beach Boulevard project is complete and has a new downtown parking lot. The City is currently working on the ASR test well project, and completed the channel redredge project. For 2012 the City plans to re-dredge the 200 channel spoil site with a FIND grant, continue to seek FEMA stabilization funding, begin the Maritime Hammock Park project as well as the median landscaping at 520 & A1A. There will be water treatment plant upgrades. A grant was approved to purchase 4 cardiac monitors. They will begin a new fire station project. A beach management plan and a new beach entrance at Minuteman Causeway is being developed.

4. Reports of Officers

- A. President Tim Ford Thanked those who came out for the ceremony for Ted Moorhead; there was a very nice turnout. The Roseland Community Association is interested in the Coalition doing a presentation at their next meeting. A letter of support for the byways bill was sent to Mica, Adams and Posey. Two support letters were requested; one for the City of Titusville billboard and one for the Anglers for Conservation for maintenance and education at the Lagoon House.
- B. Vice President Richard Stillwagon Titusville also received very nice letters from Layne Hamilton and Canaveral Seashore for the billboards.
- C. Secretary Marsha Cantrell The brochures are in and the Public Relations Committee is working on the distribution list. TDC delivered 2 boxes to the Kennedy Space Center Visitor Center and they will deliver to the 5 visitor centers in Florida.
- D. Treasurer Nicole Holbrook 1 transaction last month. There was a \$150 donation which brings the account balance to \$380. Tim is now listed on the checking account as President with signature authority. Nicole is working on the 990-N postcard; she will send out when we get the PO Box completed.

Organization History

- ♦ 1999 Began the process of developing a Corridor Management Plan lead by Ted Moorhead of the Marine Resources Council.
- 2000 The Corridor Management Plan was submitted to FDOT. The state approved and designated the Indian River Lagoon Florida Scenic Highway and the Coalition was renamed the Indian River Lagoon Scenic Highway Coalition operating under the auspices of the Marine Resources Council.
- ♦ 2002 The U.S. Department of Transportation recognized the route as a National Scenic Byway.
- ♦ 2009 The route was extended to include Pineapple Avenue in Eau Gallie, and a southern loop through the City of Fellsmere.
- ♦ 2010 The Coalition was designated a Florida not-for-profit corporation: the Indian River Lagoon National Scenic Byway Coalition, Inc.
- ♦ 2011 The Indian River Lagoon National Scenic Byway Coalition, Inc. was officially designated a tax exempt corporation under section 501(c)(3) of the Internal Revenue Code.

Goals for 2012

- ♦ Achieve Level 1 Accreditation through the FDOT District 5 Achieving Excellence Program.
- ♦ Solicit renewed community support for the Byway through partnerships with commercial and municipal interests along the corridor.
- Recruit new membership for the sustainability of the Coalition.



2. Approval of Minutes – December 1, 2011

Beth Mitchell made a motion to approve minutes as presented. Susan Adams seconded motion. Unanimously approved.

3. Reports of Committees

Sustainability Committee – Marsha Cantrell advised there was a Committee teleconference call before Christmas.

- Community Awareness/Presentations: The next presentations will be at the League of Cities and the Historic Commissions for both counties. Marsha followed up with the Brevard County Historic Commission and they typically meet the 4th Tuesday at 6:15 pm at the Cocoa Central Reference Library. Next meetings are January 24, February 28 and March 27. February or March would be the first dates we would be able to attend and make a presentation.
- Membership Database: Bob Finck discussed that he used the membership information on the current Excel spreadsheet and imported it into Microsoft

Access and that some of the information needs to be updated. The idea is to have a digital process that puts everyone's data on the spreadsheet; information can then be sorted by location, work affiliation, city, alphabetical, etc.
